PLEASE READ THE RULES CAREFULLY

THE GCCF RULES THAT NO EXHIBIT MAY BE ENTERED FOR COMPETITION TWICE IN 13 DAYS. THIS RULE INCLUDES ALL OTHER CATS AND KITTENS FROM THE SAME CATTERY/HOME. ALL CATS MUST HAVE A VALID VACCINATION CERTIFICATE.

RULE 3: In order to exhibit at any show held under GCCF licence the exhibitor must complete the official entry form for the show and abide by and subscribe to the following declaration:

3a. I/We am/are the registered owner(s) of the cats and/or kittens named on this form and I/we agree to be bound by and submit to the Constitution and Rules of the Governing Council of the Cat Fancy presently in force and to any additional rules formulated specifically for this show, provided only that the latter do not conflict with the former, and/or I/we shall have applied for registration/transfer at least 10 days before the show.

3b. No cat owned by me/us or living at the same address will be exhibited at or entered for any show or public exhibition held less than thirteen days prior to or following the date of this show/ exhibition

3c(1). In the event of ear mite infestation being diagnosed in my/our cattery/household by a veterinary surgeon, no cat owned by me/us or living at the same address will attend any show/exhibition until such time as all cats owned by me/us and/or living at the same address have been examined by a veterinary surgeon and pronounced free from ear mite infestation.

3c(2). In the event of ringworm infection being diagnosed in my/our cattery/household by a veterinary surgeon, I/we will inform the GCCF Office and neither I/we nor any cat owned by me/us or living at the same address will attend any show/exhibition until a Clearance Certificate, as required by the GCCF, has been obtained.

3c(3). In the event of any other infectious disease, with the exception of Feline Leukaemia Virus or Feline Immunodeficiency Virus, being diagnosed by a veterinary surgeon in my/our cattery/household, no cat owned by me/us or living at the same address will attend any show/exhibition until at least one month after all cats owned by me/us or living at the same address have been examined by a veterinary surgeon and pronounced free from any evidence of the disease in question.

3c(4). Cats showing a positive reaction to the Feline Leukaemia Virus blood test or the Feline Immunodeficiency Virus blood test must not be shown.

N.B. Council strongly recommends that all cats should be tested regularly.

3d. I agree to abide by any decision regarding rejection made by the examining veterinary surgeon.

3e. To the best of my knowledge, the cat(s) entered for this show has/have not been subjected to any surgery to correct any defect listed in the GCCF Standards of Points.

1 Please read the Rules carefully before entering particulars on this form.

2 Write distinctly and note that the columns must be filled in, in terms identical with the GCCF Registration form.

3 USE BLOCK LETTERS PLEASE.

4 If the age, pedigree or Breeder's name be not known, the word "Unknown" must be written in the spaces applicable.

5 Please state clearly the sex of the exhibits, i.e. M (Male), F (Female), MN (Male Neuter), FN (Female Neuter).

6 To avoid confusion, print your name and address clearly in BLOCK LETTERS as well as signing the declaration.

7 TALLIES WILL NOT BE ISSUED; PLEASE ENCLOSE A STAMPED ADDRESSED ENVELOPE FOR ACKNOWLEDGEMENT OF ENTRY

8 All exhibits MUST be accompanied by the Owner(s) or Owner's representative.

9 This entry form must be written and signed in ink, under penalty of disqualification.

10 Please note that your cat may also be handled for the purpose of assessing candidates in the GCCF Judge Appointment Scheme.
